By Direct Recruitment	5 years relevant experience as Assistant Librarian or in equivalent post in a Library of a recognized University/Law Library in case of direct recruitment
OR	OR
By promotion from amongst Assistant Librarians on the basis of merit subject to fulfillment of prescribed qualification.	Minimum 5 years experience in the feeder cadre – Assistant Librarian, in case of promotion

II. Category No. 31 Senior Assistant Librarian be deleted.
