Special Bench has been constituted on 10.04.2024 (Wednesday) at 10:30 A.M. in Chief Justice's Court comprising Hon'ble the Chief Justice, Hon'ble Mr. Justice B.R. Gavai and Hon'ble Mr. Justice Surya Kant for pronouncement of Judgment in Curative Pet.(C)Nos. 108-109/2022 in R.P.(C)Nos. 1158-1159/2021 in C.A.Nos. 5627-5628/2021. The Ceremonial Bench in Chief Justice's Court presided over by Hon'ble the Chief Justice and the Regular Benches in Court No. 3 presided over by Hon'ble Mr. Justice B.R. Gavai and Court No.4 presided over by Hon'ble Mr. Justice Surya Kant will assemble after the pronouncement of Judgment listed in Chief Justice's Court is over. Regular Bench in Chief Justice's Court presided over by Hon'ble the Chief Justice will assemble after the matters listed before Ceremonial Bench in Chief Justice's Court is over.

Hon'ble Mr. Justice Sanjay Karol will not be holding the Court on 10.04.2024 (Wednesday). Hence, sitting of Court No. 3 comprising Hon'ble Mr. Justice B.R. Gavai and Hon'ble Mr. Justice Sandeep Mehta and Court No. 9 comprising Hon'ble Mr. Justice Sanjay Karol and Hon'ble Mr. Justice Satish Chandra Sharma stand cancelled. Accordingly, the matters shown before Court No. 3 comprising Hon'ble Mr. Justice B.R. Gavai and Hon'ble Mr. Justice Sandeep Mehta in the Final list for 10.04.2024 and the Bail, Fresh and Freshly adjourned matters shown before Court No.9 in the Final List for 10.04.2024 before the Bench comprising Hon'ble Mr. Justice Sanjay Karol and Hon'ble Mr. Justice Satish Chandra Sharma will now be taken up by the Bench comprising Hon'ble Mr. Justice B.R. Gavai, Hon'ble Mr. Justice Satish Chandra Sharma and Hon'ble Mr. Justice Sandeep Mehta in Court No.3 on 10.04.2024 (Wednesday) except part-heard and specifically directed matters, if any. Dates in rest of the matters listed in Court No.9 will be notified shortly.

Hon'ble Mr. Justice Satish Chandra Sharma will take up Single Judge Bench/Chamber matters on 10.04.2024 (Wednesday) in Court No.3, instead of Court No.9 and Hon'ble Mr. Justice Sandeep Mehta will take up Single Judge Bench/Chamber matters on 10.04.2024 (Wednesday) in Court No.10, instead of Court No.3.
